By signing this registration form, I understand and am agreeing to the following:

- In consideration of being allowed to participate in the camp activities of The Italian Center and use the camp facilities and equipment for the camp fees and tuition, I, as the campers parent/guardian, do hereby waive, release, and forever discharge the Italian Center and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liabilities from injuries or damages resulting from participating in any of the program activities. Each camper participant must provide the Italian Center Camp with a valid Health Form, which must include full disclosure of any physical limitations and medical conditions that may affect his/her participation in the program. This is in accordance with Connecticut State Camp License regulations. The Italian Center adheres to a racially non-discriminatory policy.
