- In consideration of being allowed to participate in the camp activities of the IC and use the camp facilities and equipment for the camp fees and tuition, I, as the camper's parent/guardian, do hereby waive, release, and forever discharge the IC and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liabilities from injuries or damages resulting from participating in any of the program activities.
- Each camper participant must provide the IC Day Camp with a valid Health Form, which must include full disclosure of any physical limitations and medical conditions that may affect his/her participation in the program. This is in accordance with Connecticut State Camp License regulations.
- The IC adheres to a racially non-discriminatory policy. Applicants are accepted regardless of race, color, nationality or ethnic origin.
- A non-refundable \$400.00 deposit and this registration form is required in order to register my camper. All deposits, tuition and fees are non-refundable and non-transferable for any reason, including but not limited to camp closings, absences, family vacations or camp withdrawals.
